**Volume-Based Rebate** 

Rewards consistent quarterly thruput by a customer (all products combined transported from Mangalore to Hassan and Devangunthi).

Note: Revenue is a product of prevailing PNGRB tariff notified for PMHBL and the billed product volume.

Incremental Volume-Based Rebate

Encourages quarter-on-quarter growth on total thruput by a customer.

Quarter-on-Quarter Growth (%)	Rebate on Revenue (%)
Upto 5%	4.00%
above 5%	8.00%

Note: quarter-on-quarter growth is prevalent quarter of current FY vis-à-vis same quarter of previous FY.

Note: The maximum rebate applicable to any customer is a sum of both above rebates, capped at 20% of its revenue in a particular quarter.

### **Eligibility & Implementation**

### Who Can Participate?



Customers having an access agreement with PMHBL and a minimum thruput of 50,000 MT in the previous quarter and no outstanding dues.

### **How to Enroll?**



Simply submit an acceptance letter by the 15th of the first month of the relevant quarter when PUBS is applicable.

#### When Does It Start?



The scheme will be rolled out on a quarter-to-quarter basis starting on 01 October 2025 in different variants, as per business dynamics.

PMHBL reserves the right to discontinue and restart the scheme, without assigning any reasons whatsoever, at any point of time.

### **Rebate Payout**



Total revenue rebate earned by a customer in any quarter will be disbursed/adjusted in three equal monthly installments over the subsequent quarter to that customer.
